**One Annual tuition payment: If Enrollment Contract and full year payment are received by March 15, 2010, deduct 2.5% from the 2010-2011 Tuition. No Enrollment deposit is required for this option.**

**Two Semester Installments: Due on 3/15/2010 & 1/24/11. If the Enrollment Contract, \$750.00 non-refundable deposit and 1<sup>st</sup> semester tuition for a five-day program are received by March 15, you may deduct \$100 from your first semester tuition.**

The undersigned is hereby obligated to pay the entire annual tuition and applicable fees as set forth in this contract regardless of choice of payment plan, and regardless of a later decision not to attend Montessori School of Waukesha (MSW) during the contract year in question. Requests to be released from this contract must be made in writing to the Executive Director and such request does not ensure release. Release from this contract will only be granted in the case of relocation in excess of thirty (30) miles from the school, if the student is withdrawn at the request of the school, or mutual parent/school agreement. Such release refers to tuition only. **Under no circumstances will the Enrollment Deposit be refunded.** The entire payment obligation remains in effect until the Executive Director grants release from the contract in writing. Days of school missed for any reason are not refundable and may not be made up. MSW reserves the right to recover legal fees necessary to enforce this enrollment contract from the applicable parent(s). Your child will be enrolled in the program(s) selected when the school receives the **completed and signed Enrollment Contract and the Enrollment Deposit and provides a confirmation copy of this contract.** Enrollment of any child in a selected program is subject to prior teacher or administrative approval. **Please make checks payable to:** Montessori School of Waukesha. The undersigned agrees to pay the annual tuition, in one of the methods listed above, for applicable curricular programs as set forth in the latest tuition schedule. The \$750 Enrollment Deposit will be applied to your account on or about January 24, 2011, as long as your account is current. Your child's position in the program(s) selected will not be secured until this Enrollment Contract is completed and returned with the Enrollment Deposit for each child.
